- 90°F to 100°F. If not within this range discard/recollect Label one vacuette tube with Patient name (first and last) and DOB
- Continue with transfer from cup to vacuette
- Remove seal from the top of the collection cup lid
- Invert labeled tub onto the spike on the cup
- Fill tube completely or until it will no longer fill Clean cup and vacuette and place in transport bag along with requisition w/ ICD-10, face sheet, medication list and insurance card front/back

- STORAGE/TRANSPORT INSTRUCTIONS
- At room temp 15°C to 30°c for 7 days before analysis
- Refrigerated 2°C to 8°C for 14 days before analysis Frozen -15°C to -20°C for 30 days before analysis
